- If submitting entry by mail, please include a self-addressed stamped envelope (S.A.S.E.) so a ticket stub(s) can be returned to you. If no S.A.S.E. is included with the entry form, a return ticket stub(s) will not be provided to you. This has no effect on drawing eligibility; however, you will have no official receipt of your drawing number for your records.

- Entry is by submission of an entry form by mail or in person. If forms are submitted in person a \$5 donation per ticket will be accepted in the form of cash, check or money order payable to Scrambler Owners Association. If forms are submitted by mail a \$5 donation per ticket will be accepted in the form of a check or money order payable to Scrambler Owners Association. All net proceeds from these donations will be split equally between St. Jude Children's Research Hospital and BlueRibbon Coalition;

- For those persons entering without the \$5 donation, a separate "opt-out" note must be submitted in lieu of the \$5 donation. This separate "opt-out" note must be submitted on a 3" X 5" card with the person's name, address, telephone number, (optional) e-mail address, and the following hand-written statement: "I wish to enter the Scrambler Owners Association Drawing without a \$5 donation, and acknowledge that all net proceeds from this donation would have otherwise be split equally between St. Jude Children's Research Hospital and BlueRibbon Coalition". For those persons entering with a donation less than the \$5 donation, a separate "opt-out" note must be submitted on a 3" X 5" card with the person's name, address, telephone number, (optional) e-mail address, and the following hand-written statement: "I wish to enter the Scrambler Owners Association Drawing with a donation of less than \$5, and acknowledge that all net proceeds from this donation will be split equally between St. Jude Children's Research Hospital and BlueRibbon Coalition".
